The overwhelming complexity of the legal system is compounded when financial barriers are present. Hit hardest during family transitions are low-income families - especially children. During such times, financial pressures can become unbearable and the home environment begins to or more precipitously unravel, causing legal needs to skyrocket. Continued on Schedule O.
